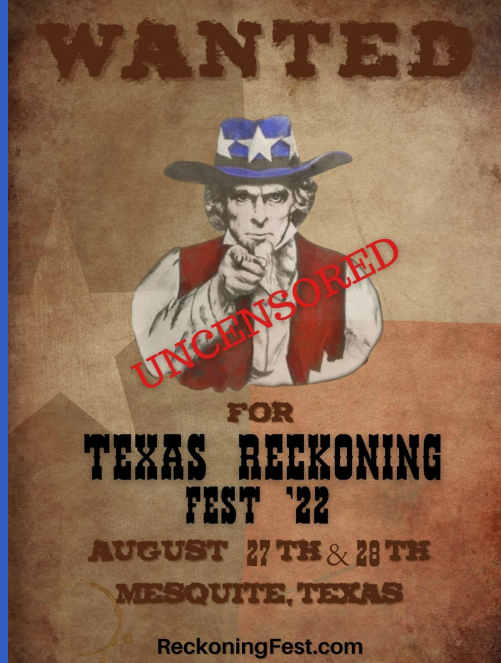

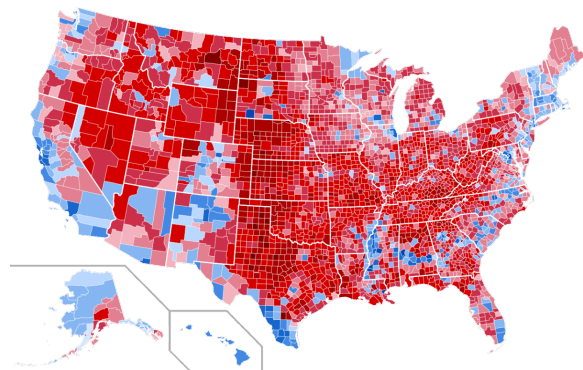

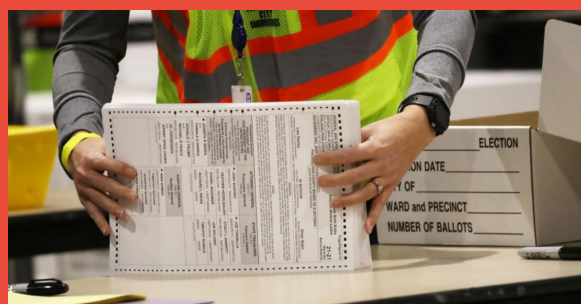

Executive Summary

The Electronic Registration Information Center, ERIC, and the Center for Election Integrity and Research (CEIR) are two entities that enjoy 501(c)(3) status. Widely known information is summarized first and followed by new information learned about these organizations from a series of FOIA requests submitted to several states.

Known Issues

- ERIC was founded in 2012 by David Becker while he was working at Pew Charitable Trusts. It was reported that Becker wanted to create a national voter list but realized that the states would not approve it. So, he created ERIC as a membership based organization as an alternative.

ERIC Sharing Data with Zuckerberg-Funded NGO

ERIC was allegedly established to help states make voter rolls more accurate. The primary effect of ERIC is to grow the voter rolls by converting eligible-but-unregistered (EBU) persons into registered voters.

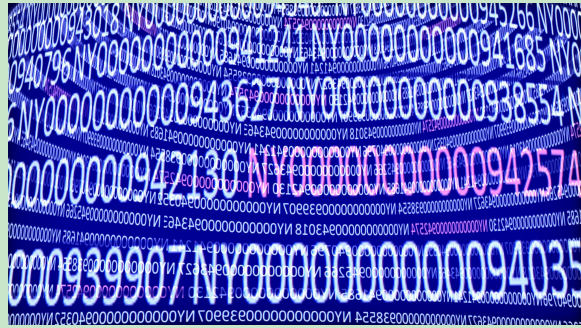

FROM OUR CHAIR

Lots to celebrate as Primaries across our country have elected America First candidates for the November election. However, if you watched the returns, you heard the conservative voter turn-out was low, attributing it to what's going on in Washington. This is historically true right here in Bexar County so we here at BCEI are asking all our members to start today, educating those around you, as to the importance of going to the polls. Regardless of what's happening in DC, we must take care of our city which starts at the polls.

If Abbott wins the majority of precincts in Bexar, i.e. 60%, our party will place conservative election judges in 60% of the early voting polling sites. This is huge and allows election integrity to be front and center during early voting which is when approximately 80% of the votes are cast. In other words, our party would control the polling sites making sure there's complete chain of custody of all election records so let's make it 100% of the precincts and take over Bexar County elections.
