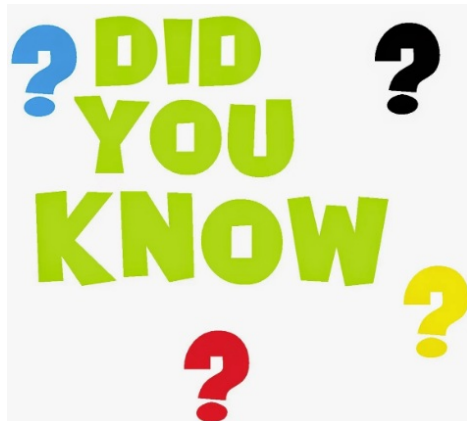

## [A Powerful Strategy to Combat Mail-in Ballot Fraud!](#)

A powerful strategy is to have each person who receives a mail-in ballot bring it to the election poll and vote in person on the day of the election. This prevents the other side from knowing your vote in advance and it proves that your mail-in ballot has not been voted by you. If someone has voted for you in your place, you can notify a sheriff and file a criminal complaint, plus notify the election judge and demand your vote count.

If you won the lottery, would you mail in your ticket or go in person?



You may qualify for a mail-in-ballot but if you can get in the car, please go in person. The election worker will bring a mobile voting machine to your car.

If you've applied for and received a mail-in-ballot just take it to the poll with you. The election judge will take it, cancel it, and you can vote in person.

If you need a ride to the poll, VIA will take you, free of charge. More info in our next newsletter.

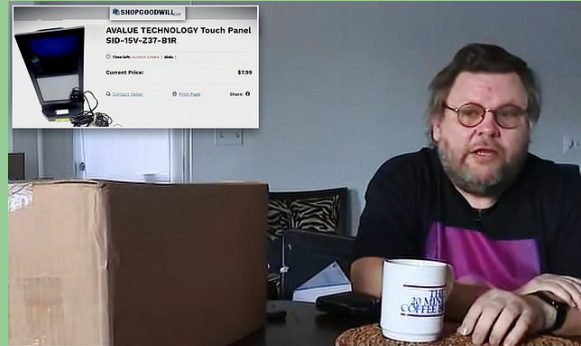

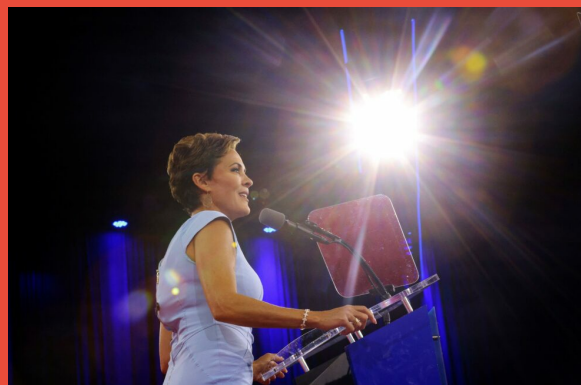
