Senator Hall understands the lack of accuracy and transparency and he's on a mission to change it. We are headed back to Austin January 24 to let our representatives know we need election reform. 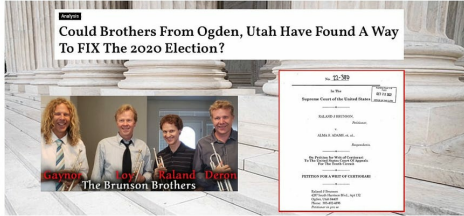
